





REPORT ON LWI GRAND HEALTH BAZAAR GHB2013

ABSTRACT:

The LiveWell Initiative LWI Grand Health Bazaar GHB2013 was a multisectoral, cross-cutting international annual healthcare exposition, plenary and health fair programme, which took place at the Havilah Centre, via Sheraton Four Points, Oniru Road, Victoria Island, Lagos from Wednesday April 17th – Friday April 19th 2013.

GHB2013, a '3-in-1' event made up of an Exposition, Plenaries and an adjoining Health Fair; was run on the heels of a very successful inaugural GHB2011 and 'an even more successful' GHB2012 which were both held also on Victoria Island, Lagos. GHB2013 was held out of the need to further foster collaboration between the health sector and the organised private sector with a view to attain mutual synergy between these groups; to bring about improvement of general health and health literacy in our society and enable commerce, corporate networking and synergistic collaborations.

To enhance participation and create a more interactive GHB2013 event, thematic plenary sessions were introduced as follows:

Day 1: April 17th 2013: Oil & Gas/Power Day - 'Power and Energy: a Boost to the Eco System and Robust Health'

Day 2: April 18th 2013: Property / Real Estate Day - 'Building in Safety and Safety in Buildings: a Learning Continuum'

Day 3: April 19th 2013: Aviation Day – 'Travellers' Medicines and 'in-flight' Healthcare

GHB2013 was a carnival-like event with the presence of organisations from different sectors of the economy. It was officiated by over 250 officers from over 141 companies/organisations and about 3,000 participants (by daily cumulative contact) numbering just about 1,000 participants by day attended the event from all sectors of the economy. The turnout of invited dignitaries and exhibitors were as high as 90%. Participants' turnout also met a high expectation and the corporate sector representation was excellent. GHB2013 was by all ratings and feedback, a very successful and impactful 3in1 event.

PREAMBLE:

LiveWell Initiative LWI as a health empowerment organisation, has taken upon itself, the responsibility of improving 'health literacy' and 'wellness' for the goal of advancing healthcare, improving health outcomes and filling the gap in healthcare in Nigeria and on the African continent. Thus, our several programmes have branched into the markets, taxi parks, mechanic villages, schools, conglomerates, banks, rural, semi urban, and cosmopolitan areas of society. In spite of this concerted effort, a further social gap was identified, one in which the working-class, the professionals, the middle-class and the elites were identified as neglecting issues pertaining to their health. To fill this void, the idea of a 'fun-but-formal' event, which would attract corporate people, devoid of too much formality but formal enough to drive home a few key points about their health, was formulated. This led to the

This led to the idea-generation, programme synthesis, marketing strategy and event actualisation of the inaugural GHB2011 – with the theme 'Health and Wealth Partnerships on the move...' which took 15 months to plan and implement; the GHB2012 – with theme 'Health and Wealth Partnerships at the next level...' took place on the heels of a very successful GHB2011; and then GHB2013 was formulated with the theme 'Sustaining Wealth Creation through Health Solutions and Partnerships', off the back of an even more successful GHB2012.

INTRODUCTION:

The Grand Health Bazaar GHB2013 was a business-focused, collaboration-building and cross-relationship targeted healthcare exposition, designed for promoting health and health literacy, commerce, inter-activity and networking. It attracted different stakeholders from various sectors of the economy – the Oil & Gas Sector, Power and Energy Sector, Property / Real Estate Sector, Aviation Sector, Media Houses, Banking Sector, Telecom Companies, HMOs, Health Insurance Companies, Pharmaceutical and Medical Industry, Manufacturing Companies, Schools and Tertiary Educational Institutions, Government Organizations, Inter-government Organisations, Hospitals, Clinics, Pharmacies, Food and Beverages Industry, International Organisations, Foundations, Technocrats, Diplomats, Entrepreneurs, High Net-worth Individuals, Philanthropists, Healthcare Practitioners and the General Public.



PREVIOUS ENDORSEMENTS: A REASON FOR AN 'ENCORE'

The LWI GHB2011 was the first grand health multisectoral bazaar in the nation that focused on women's eHealth, 'Heart' Health and Adult Immunization. The GHB2011 attracted endorsements and accolades from the following organisations among others:

- GHB2011 and GHB2012 brought together all sectors of the economy to a congruent point of synergy for healthcare with several new inter-corporate affiliations
- GHB2012 was even more successful, with accolades from all quarters. The US Consul General Mr. Joseph Stafford attended in person and was the event Patron at GHB2012. Among other representatives were the DGWAHO and WR of WHO. OBJECTIVES OF GHB2013:

- i) To generate cross-cutting solutions to the efficiency challenge in the health system through the initiation of cross-cutting collaborations
- ii) To institute cross-sectional networking, affiliations and mutual synergism
- iii) To bring the health sector face-to-face with its consumers in an informal setting with a view to promoting direct-to-consumer interaction and consumer-to-health system communication
- iv) To promote commerce and cross-relationships in a 'fun-but-formal' environment

GHB2013 VENUE, THEME, SUB-THEMES AND THE PLENARIES:

The GHB2013 event took place at the Havilah Centre, via Sheraton Four Points, Oniru Road, Victoria Island, Lagos from April 17th – 19th 2013, had highly placed technocrats and panelists of diverse backgrounds discussing various thematic topics in relation to the theme of the event, which was 'Sustaining Wealth Creation through Health Solutions and Partnerships' In line with the theme, the underlying thrusts of the GHB2013 were focused on three (3) daily key areas of thrust, at the GHB2013 namely; Oil & Gas / Power Day, Property / Real Estate Day, and the Aviation Day.

i) Day 1: April 17th 2013: Oil & Gas / Power Day at GHB2013: with the sub-theme 'Power and Energy: a **Boost to the Eco System and Robust Health'**. This sub-theme focused on the oil and gas / power sector. His Excellency Gov Babatunde Raji Fashola, SAN, declared the event open through the Honorable Commissioner Ministry of Energy and Mineral Resources MEMR Lagos State, Engr. Taofeek Tijani, who attended the event with a high-powered team of oil and gas experts including two Senior Special Advisers to His Excellency Gov Babatunde Raji Fashola (SAN) on MEMR. The Honorable Commissioner MEMR Engr. Taofeek Tijani chaired the first plenary session of the GHB2013 event in his own personal recognition as Honorable Commissioner of Minerals and Energy Resources, Lagos State. The Hon Commissioner of Health Lagos State Dr Jide Idris, ably represented by Hon PermSec Health Lagos State, Dr Femi Olugbile, in his opening remarks at GHB2013, which drew attention to the hazards that arise from oil and gas operations, which stressed the *importance of synergizing health, power and energy*. There were two plenary sessions. The Hon Commissioner - Lagos State Ministry of Energy & Mineral Resources MEMR - Engr. Taofeek Tijani led the first plenary session, of which the plenary speakers included NESG Chairman Mr. Folusho Phillips, NERC Chairman Dr Sam Amadi represented by Chief of Staff Dr Chikwerem Obi, Oando Energy Resources Community Relations Manager Chief Samuel C. Onyenwe, and Government Relations/Regulatory Compliance Ms. Isaac Abigail. IESL Chairman Dr Diran Fawibe represented by Business Strategy & Development Manager Mr. Tunde Tella led the second plenary session, where the plenary speakers included WAWA Country Focal Person/Regional Chair & WOCAN CEO/Founder Chief (Mrs.) Beatice O. Ubeku, IESL HR Manager Ms. Eseoghene Omadevuae and QAQC Manager Mr. Akeem Mustapha. The plenary sessions highlighted significant challenges of petroleum and energy production, which affects the eco-system and health of individuals. Attention to community engagement, job opportunities, education, and participation were noted as successful means of sustainability.



- ii) Day 2: April 18th 2013: Property / Real Estate Day at GHB2013: with the sub-theme 'Building in Safety and Safety in Buildings: a Learning Continuum'. This sub-theme focused on the property / real estate sector, with a view of highlighting the problematic occupational safety and health issues arising in the construction industry. Jaykay Pharmacy Group CEO, Pharm (Hon) Jimi Agbaje led the first plenary session, where the plenary speakers included Delano Architects Principal Architect Mr. Roti Delano, and Nehemiah Resources Investments Ltd Chief Resource Officer Mr. Adeniyi Aromolaran. The second plenary session was chaired by UPDC CEO Dr Hakeem Ogunniran was represented by the Director of Technical Operations Mr. Brian Greenaway. The second plenary speakers included DFID Regional Director Dr Sina Fagbenro-Bryon, and Osun State Ministry of Lands & Housing Special Advisor and Physical Planning & Urban Development Dr Isaac Owoade, ably represented by Permanent Secretary Lands & Housing Osun State, Architect Mr. Wale Ojo. Both plenary sessions were very stimulating and shed light upon the dangers of not delivering sound and safe systems in the Nigerian building sector. The discussion in suitable design, quality control, assessing environment impact, personal protective equipment PPE, emergency procedures, as well as continued implementation of management services are paramount in sustaining safety and preventing health issues encountered during building/construction and operations.
- iii) Day 3: April 19th 2013: Aviation Day at GHB2013: with the sub-theme 'Travellers' Medicines and 'inflight' Healthcare. This sub-theme focused on the aviation sector, with a view to examining the challenges of air travel with regards to individuals' health. The Mozambique Ministry of Health National Director for Planning & Cooperation Dr Celia Gonçalves chaired the plenary session. The plenary speakers included United Airlines Country Director Mr. Gary Bidmead represented by Business Manager Mr. Oladele Taiwo, So Aviation (Sahara Group) CEO Mr. Alistair Morrison represented by General Manager Commercial Antonella Saldo, Pfizer NEAR Director Regulatory Affairs Mrs. Bunmi Femi-Oyekan, MD Skylogistics / Representative Delta Airlines Nigeria Mr. Olufemi Adefope, and UNILAG College of Medicine Provost Prof. F.T. Ogunsola. The plenary session was very insightful. Emphasis on the importance of health status of customers, employees and products through continued training, maintenance etc. are key in achieving sustainable developments in the aviation industry.

THE EVENT:

Over 141 prominent companies and conglomerates attended and exhibited at GHB2013; and among the daily groups of delegates and attendees were from Skye Bank Plc, Lagos and Osun State Government, Oando Plc, Nigeria Economic Summit Group (NESG), United Airlines, Standards Organisation of Nigeria (SON), Ekulo Group of Companies, UACN Property Development Company Plc (UPDC), Nigeria Electricity Regulatory Commission (NERC), So Aviation (Sahara Group), BusinessDay, CTL Africa Trend TV, International Energy Services Ltd. (IESL), Airtel Nigeria, Energy Group, GlaxoSmithKline GSK, Vitabiotics/Adler, Oxford Business Group, Forever Living Products (FLP), Mobitel Ltd., Nestlé Nigeria, THT/Liberty Health Blue HMO, May & Baker Nig. EVENT STATISTICS:

Exhibitors: In all 80 exhibitors covered the 3-day event, which was set in a classy and professional ambience. There was a cross-sectoral presence of companies that cut across from the Oil Energy & Gas, Aviation, Property and Real Estate Sectors, Healthcare Organisations/Clinics to the Pharmaceutical Companies, Banks, Manufacturers, Non-profit Organisations NGOs and Foundations, Telecommunications, Food & Nutrition Industry, Beverage Companies, Conglomerates and Commercial Entities.

The 31-man LWI team members gave full healthcare cover to all GHB2013 participants. They operated an adjoining 'Free Health Fair at GHB2013', from the 'wellness stands', which offered free healthcare checks in a classy and friendly atmosphere devoid of the typical 'hospital-feeling'. The LWI free health stands offered free basic health checks to all willing attendees at GHB2013 including Stress Testing, Body Model Index BMI, Blood Pressure, Blood Sugar, Cholesterol, Malaria and Hepatitis B Screening Tests as well as Free Medicines to all. In addition to the above services, which were offered free with courtesy and accompanied by the 'LWI SMILE', there were personalised health counselling services on Men's, Women's, Family and Reproductive Health. The LWI team was made up of medical doctors, pharmacists, nurses, public health officers, trained counsellors and skilled professionals, among whom were Masters degree holders and LBS (Lagos Business School) graduates of the organisation.

GHB2013 PARTICIPANTS:

Cumulatively, at least 3,000 participants attended the 3-day exposition; with a mixed attendance composed of oil & gas professionals, real estate and aviation professionals, healthcare professionals, bankers, students and various high-leveled professionals from all walks of life. Some attendees even sent their relatives to GHB2013 including children and elderly parents. All populations were represented at the GHB2013; however, the majority of attendees at the 3-day busy GHB2013 were Professionals and Technocrats, as well as a significant number of Students from higher institutions and colleges.

- Great branding from the exhibitors; the venue was competitively branded externally and internally
- Great entry impression; the layout was impressive and the venue was a beehive of activities throughout the 3-day duration; with great attendance and enthusiastic participation
- A **Pre-Event 'Wine and Cheese' Cocktail** was hosted by LWI at the Silverbird Galleria, Victoria Island on Friday April 12th 2013 from 4pm 7pm. The pre-event was very successful, as it was well attended by HNIs (High Net-Worth Individuals) from various sectors of the economy; about 16 partner organisations and at least 9 speakers attended
- Very Busy Activity Profile; Product Mini-launches, Several Product Activations and Multiple Product Samplings
- GHB2013 atmosphere was generally boisterous, happy, fulfilling and rewarding. It conveyed 'good health' in unwritten terms
- A number of high-level professionals attended, various individuals from different sectors of the economy, including the academic institutions
- Every participant at the GHB2013 was issued a Certificate of Attendance by LiveWell Initiative LWI
- Great 'mix' of organisations the 'cross-cutting' effect was evident as the organisations were multi-sectoral
- The Lagos State Government was Event Parton and Chief Event Partner, which was prominently represented by its top officials at the MOH and the MEMR including the delegates who turned up in large numbers
- Many interested organisations have emerged preparatory to the GHB2014 programme
- GHB2013 has been rated the 'best' programme, LWI has held so far in terms of partnerships, growth and spread

- Free daily breakfast, Free daily water, Free daily servings of Juices, exotic drinks and sparkling wines spiced up the event profile and promoted the GHB2013 event profile
- High Profile Dignitaries, Schools, Women Groups and Institutions in attendance broadened the event scope and coverage, thus heightening and enriching the GHB2013 event profile and adding great value

LEARNINGS / LIMITATIONS:

- The Target audience attendance was quite great. More corporates would be implored to release their staffers to attend next year's GHB2014, to attain even higher attendance goals.
- 'Stay' attraction was included in GHB2013 to retain visitors longer at the exposition, to make it even more carnival-like. This was a successful strategy, courtesy of Go2Gurl Ltd, GHB2013 Event Managers
- A two-day event would be less capital intensive and more cost-effective than a 3-day event
- Protocol and concierge formalities for international engagements including translators, may need to be built into future GHB events.

BENEFITS TO PARTICIPATING ORGANISATIONS:

In line with the objectives of GHB2013, participating organisations benefited tremendously from the unique event, which recorded great success and impactful outcomes.

Deliverables attained include but are not limited to the following:

• The cross-cutting, multisectoral nature of the event enabled companies the opportunity to build new collaborations and partnerships by seeking out clients in the non-traditional sectors



- Many corporate seized the opportunity to consolidate in the Nigerian market through a unique corporate exposition business to business and direct-to-customer; commerce and networking
- GHB2013 provided ample opportunity to mingle with other sectors of the economy at large, with great prospects of a mutually benefitting synergism to this end, no corporate entity interviewed at GHB2013 made less than 30 new corporate friends!
- Opportunity to obtain new ways of attaining positive educational outcomes and engaging with participants of schools and academic institutions
- GHB2013 participation has conferred on partners and exhibitors, an enhanced Corporate Social Responsibility (CSR) and Sustainability Profile in the eyes of the Public by positively impacting the lives of communities as well as the health sector
