

# STRATEGIC HEALTH SECTOR FOCUS GROUP CONVENED BY LIVEWELL INITIATIVE LWI

### Background:

LiveWell Initiative LWI (RC: 692490), a self-sustaining non-profit healthcare organization, which has outreached over 1.5 million Nigerians and over 3,000 Ghanaians with health literacy and empowerment since its inception nearly 6 years ago, convened a Stakeholders **Strategic Health Sector Focus Group Meeting** on *"Promotive Healthcare"*, which held on Wednesday 31<sup>st</sup> of July 2013 at the LWI Head Office, FBA Suites, 2<sup>nd</sup> Floor, Plot 5, Chief Yesuf Abiodun Way, Oniru Road, Victoria Island, Lagos.

## **Objective of the Focus Group:**

To facilitate wellness promotion and health status awareness among the populace through a proactive and deliberative strategy.

#### **Deliberations:**

The discussion was centered on *promotive healthcare*, with focus on the following palpable health threats:

- Hepatitis in Africa
- Executive Health / Workplace Wellness
- Poverty Illness
- Non-Communicable Diseases (NCDs)
- Nutrition and Health
- Maternal, Newborn and Child Health (MNCH)

At the end of the deliberations, a *Communiqué* was issued to reflect the joint opinions of the focus group members, with a view of paving the way for subsequent implementations of an evolving ACTION PLAN by Government partners, NGOs and Stakeholders.

A COMMUNIQUE ON THE LWI STRATEGIC HEALTH SECTOR FOCUS GROUP MEETING ON PROMOTIVE HEALTHCARE HELD AT LWI HEAD OFFICE, FBA SUITES, 5 YESUF ABIODUN STREET, VICTORIA ISLAND, LAGOS ON THE 31ST OF JULY 2013.

**Objective**: To facilitate wellness promotion and health status awareness among the populace through a proactive and deliberative strategy

The participants (see list below) discussed the following topics and recommendations, and agreed that further ideas as to implementation and execution will be discussed at future meetings.

- Communicable Disease Hepatitis Given the prevalence of Hepatitis in Africa, and with special focus on Hepatitis in Nigeria; screening and testing should be made available to the entire population. This can be done effectively through raising awareness and making testing available through such events as health fairs. Highlights were thrown into the efforts by Lagos State, which has instituted a hepatitis epidemiological survey. Those who test positive should be educated as to how to minimize transmission, and treatment for hepatitis B and C should be made widely available.
- Executive Health / Workplace Wellness Health Professionals and Consumers of healthcare services need to be knowledgeable and to have a preventive focus. Collaborations need to be built and Safety Standards need to be defined across the health sector. SPDC has made important inroads in the prevention of illness and injury through training and hazard awareness, and its occupational health program can be used as a prototype for other companies. The risk hazard management protocol should be used in the following order: Elimination, Engineering, Mitigation and Treatment EEMT. Occupational illness and injury should be treated immediately to avoid secondary complications due to delay in care. Companies should train employees as First Responders with roughly 1 in 10 staffers receiving full first aid CPR training in order to deliver emergency health services. Also, offices should be furnished with adequate life-saving equipment such as automated external defibrillators (AEDs), which should be a legal requirement alongside safety requirements, e.g. fire extinguishers. Office buildings should house at least two trained and certified first aiders on every floor. AEDs are life-saving devices and should be placed in public areas and within all public buildings, with appropriately trained personnel.

- **Poverty Illness and Non-Communicable Diseases (NCDs)** Due to the burden of disease, which is a multidisciplinary, multiagency affair, healthcare services should be made available to the general population. The Media has a role to play in Health Education and Promotion, galvanizing the multidisciplinary multiagency roles, disseminating health information, and improving access to care. The starting point should be ADVOCACY, AWARENESS and thereafter there should be Leadership by Government and the Private Sector, and lastly, Legislation and Enforcement. Health insurance should be offered to workers through their employers so they can access care. Out of pocket expenditures for healthcare should be minimized with community health insurance for the informal sector and for poorer populations who pay for health out of pocket. Preventive measures should be emphasized in order to avoid loss of health, financial costs of treatment, and loss of ability to work, which can lead to further impoverishment. A lack of awareness and understanding of current public health resources including the Community Based Health Insurance Scheme (CBHIS) exists which results in wasted resources due to under-utilized staff. Raising awareness of this, health fairs, screening opportunities, and other healthcare resources must be made a priority.
- Partnerships The key to reaching the grassroots population and sustainability of healthcare initiatives is through People Public Private Partnerships PPPPs. The key to raising awareness is by forming an alliance with the press/media, which has the scalability to reach millions of people at once. A media representative, a Financial Specialist, and Patients should be identified and invited to future meetings of the LWI Strategic Health Sector Focus Group. Media outreach should be performed with a goal of transforming media representatives into public health advocates who will embark on communications campaigns. The government, non-profits (including NGOs) and private enterprise should solicit all forms of media such as radio, television, online and print. Media empowerment can be further facilitated with basic health education. For example, social media such as blogs, Facebook and Twitter may be used to create awareness of service offerings by primary health centers in Lagos. Additionally, communities should be involved as stakeholders and not just beneficiaries, e.g. PATH 2 Module.

• Maternal, Newborn & Child Health (MNCH) – The significant maternal mortality rate MMR statistics in Nigeria, was a key source of concern to the focus group. DFID provided information on its efforts within the community, and, the need for collaboration between the communities and the health system. The negative socio-behavioural and attitudinal response of low literacy women to the health facilities was responsible for high MMR and the statistics can be brought down through the community engagement programmes. The topic was in exhaustive and was therefore further deferred for discussion at a future meeting.
